## Statement by South Sudan at the 57<sup>th</sup> annual session of the Joint Advisory Group of the International Trade Centre (ITC)

Thank you Madam Chairperson. Distinguished participants,

On behalf of the Government of the Republic of South Sudan, allow me to first congratulate you for presiding over this 57<sup>th</sup> Annual Joint Advisory Group meeting of ITC.

Excellences, Ladies and Gentlemen,

The Government of South Sudan acknowledges the importance of the trade development technical assistance that the International Trade Centre (ITC) provides to its beneficiary countries globally, including to the Republic of South Sudan. We are pleased with the progress of implementation and achievements made thus far of the various projects ITC has been implementing in South Sudan, including the South Sudan Jobs Creation and Trade Development Project and the National Export and Investment Strategy Development Project.
