CULTIVATING SUSTAINABILITY: PROPELLING SUSTAINABLE TRANSITION OF MALAYSIA'S AGRI-FOOD SECTOR

CHALLENGES AND OPPORTUNITIES

The global demand for sustainable food creates opportunities for Malaysian businesses in international markets. The Malaysian agrifood sector, especially Micro, small and medium sized enterprises (MSMEs), faces challenges for investing in modern technologies and meeting global standards. It also encounters hurdles in agri-product exports to the European Union (EU), due to contaminant interceptions, and with new market import regulations.

RESULTS AND IMPACT

ARISE Plus Malaysia contributed to harmonize Malaysia's agricultural practices with the Association of Southeast Asian Nations (ASEAN) and European Union (EU) standards and best practices, not only promoting environmental responsibility but also strengthening the country's global trade potential. The project supported the Twelfth Malaysia Plan and its objectives to develop sustainable agriculture.

The project worked in close partnership with the Ministry of Agriculture and Food Security, the Ministry of Plantations and Commodities, as well as the Department of Agriculture (DOA), the Department of Fisheries (DOF), and the Department of Veterinary Services (DVS). Approximately 1,000 participants from 190 organizations benefited from project capacity building activities related to sustainable practices in the agriculture sector.

The project approach was threefold: a palpable sense of ownership among stakeholders, active private sector participation facilitating direct collaboration, and a dedicated outreach strategy extending the initiative's impact to officials and SMEs in Sabah and Sarawak.

Key results:

- Crucial aspects of sustainable agriculture addressed, from fertilizers and integrated pest management to biosecurity, traceability, and epidemiology in the fishing sector, in line with EU policies, legislation, and regulatory frameworks.
- Malaysian Fertilizer Act and Integrated Pest Management Action Plan formulated, both aligned with best global practices.
- Lessons learnt from the EU to identify measures to address remaining audit recommendations in the fisheries sector, aligning biosecurity measures to international and EU standards, and develop a traceability system for the fisheries sector.
- Promoted MSMEs' resource efficiency and circular production (RECP), as well as compliance with Voluntary Sustainable Standards (e.g., Ecovadis, PEFC, BRCGS, and FSSC 22000).
