The Philippines is glad to continue our cooperation on the SheTrades initiative, which reinforces our country's commitment to promoting women's economic empowerment, and has provided women entrepreneurs and women-owned SMEs with a unique network and platform to connect to markets. We remain open to sharing good practices such as our Startup Pinay initiative, recently highlighted in the Outlook report, and look towards intensified collaboration in the SheTrades Global event. We are also supportive of the ongoing creation of a global network of government focal points to further strengthen and institutionalize work on trade and gender.

We look forward to continued collaboration with ITC on the ARISE Plus Philippines to foster inclusive economic growth through improved international trade performance and competitiveness. We note the early successes of this partnership though work on start-ups and youth entrepreneurship and express our interest to explore capacity building on digital trade, sharing of best practices on investment facilitation, and maximization of trade agreements – for instance, business guidebooks to increase preference utilization rates. Likewise, as our new administration has increased its focus on climate mitigation and adaptation by proposing more than a 50% increase in its climate change related expenditure, we would likewise look towards complementary support that would embed green business practices among our MSMEs.
